Low Appraisal Gap Clause

In the event any appraisal secured by Buyer establishes a value less than the "Purchase Price," Buyer hereby agrees to pay the difference, not to exceed \$_____ in cash. Regardless of the above, in no event shall the Seller be required to accept any purchase price less than the amount set forth in the purchase agreement.
